# Water meters proposed for Edgecumbe

Edgecumbe residents and property owners will be asked for feedback on a proposal to install water meters on all water connections in the town.

The cost involved has been built into the Plains Water Scheme upgrading options proposed by the Whakatāne District Council, which will be subject to a public submissions process through its 2016/17 Annual Plan community consultation.

Council elected members highlighted a number of positive outcomes the metering of individual connections would provide. These included:

• Future resource consents are likely to require meters, to encourage the efficient use of water resources. Installation as part of the Plains Scheme upgrade would allow this to be achieved at no cost to property owners

Edgecumbe's water consumption per person is almost three times higher than in other District

communities (600 litres per person per day, compared to 220 litres elsewhere), which indicates that there are significant leakages in the reticulation system, either on private property, or from Council-owned water mains

- Metering will help to identify the sources of water leaks and allow the problem areas to be addressed
- Individual metering will mean each property only pays for the water it uses. Properties which do not have leaking water lines could therefore expect a much lower usage cost than they currently pay

Information on the metering proposal will be made available to all Edgecumbe residents towards the end of March. Submissions on the proposal can be made between 21 March and 22 April and will be heard by the Council in early May.

On 2-3 April, 2016, teams of four will walk either 50 km or 100 km across our stunning District. At the same time, they will be challenging poverty by fundraising to help save and improve lives as well as feeling absolutely awesome for doing it.

# Annual Plan draft budgets approved

The Whakatāne District Council's Policy Committee has approved draft budgets for the 2016/17 Annual Plan which would see an average rates rise across the District of 3.2 percent.

A report detailing financial forecasts for the year and setting out proposed community consultation processes was received by the committee last week. In the report, Finance General Manager Helen Barnes noted that several matters currently under consideration could have an impact on the final Annual Plan, and that a number of assumptions had been built into the forecasts. These included the removal of planned 2016/17 capital expenditure for Matatā wastewater reticulation, and the inclusion of additional capital expenditure and associated operating and financing costs for proposed Plains Water Scheme improvements.

The indicative average rate rise is slightly higher than the 2.96 percent estimate reported to the Council in December last year, although it is still substantially lower than both the 2015-25 Long Term Plan forecast (3.84 percent) and the limit set out in the Council's financial strategy (4.1 percent). The average rate rise across the District for the 2015/16 year was 3.21 percent.

While the report confirms that the financial forecasts comply with all of the Council's financial strategy limits, and are largely in line with the work plan and budget forecast in the Long Term Plan, it concludes that the proposed Plains Water Scheme capital expenditure does trigger the need for formal public consultation. A consultation document summarising key elements of the 2016/17 Annual Plan, including the indicative rates costs applying to various communities and sectors, will be

reported to the Committee on 17 March and made publicly available via a fourpage supplement to be published in a local free-delivery newspaper. At the same time, community feedback will also be sought on proposed changes to resource consent fees and the Whakatāne District's draft Gambling Policy.

Copies of the proposed consultation document, supporting reports and submissions forms will be available from Council offices and on the Council website.

Submissions to the Annual Plan will open on 21 March and close on 22 April. Submission hearings are scheduled for 5-6 May, and the Council will then deliberate on any changes required before adopting the final 2016/17 Annual Plan and fees and charges schedule on 23 June.

### **HOW WE SEE IT** WHAKATĀNE CAMERA CLUB 18 MARCH - 1 MAY

# Community input needed for Gambling Policy review

A draft Whakatāne District gambling policy and draft Social Impact Assessment will be available for community input next month, alongside the Whakatāne District Council's 2016/17 Annual Plan.

The Gambling Policy (Class 4 Venue and Board Venue) focuses on non-casino gaming machines (or 'pokies') and Board Venues (stand-alone TABs) and, as required by the Gambling Act 2003 and Racing Act 2003, must be reviewed and made available for community submissions every three years.



The draft Social Impact Assessment concludes that the Whakatane District has a medium risk of harm from gambling activities and that the level of risk has not changed significantly since the last review. Based on its findings, the draft gambling policy proposes limiting the number of gaming machines to 141 (six per 1,000 District residents over the age of 18). Because the District now has 181 gaming machines in 13 venues (down from 245 in 19 venues in 2003), that would effectively mean that no applications for new machines could be approved until the total number of pokies in the District falls below 141. In adopting the draft policy for public consultation at its meeting this week, the Council's Policy Committee also asked for changes to be incorporated which would limit the location of new gambling venues in areas with the highest levels of gambling risk.

The proposed policy also limits new Class 4 and Board Venues to locations that are zoned as 'Business Centre' in the proposed District Plan, and that are at least 50 metres away from premises with sensitive uses, such as schools and churches. An additional section has been included which proposes that applications to relocate existing Class 4 Venues will be treated as new applications, except in specific, exceptional circumstances.

Public submissions on the draft policy open on 21 March and close on 22 April. Hearings of submissions are scheduled for 5-6 May, and the Council will then deliberate on any changes required and adopt the final Gambling Policy.
