Rural people have responsibility and pride in the land

## What isn't good about the rural area?

Conflict of uses and reverse sensitivity eg piggeries Attitude of people attracted to lifestyle blocks Pollens Council focuses on CBD, neglects the rural sector Mind shift in Council towards rural life and rural towns No attention to how people live in the rural towns eg Te Teko Water supply dubious, rural water supplies need work Wastewater systems insufficient Not adequately budgeted Rural roads and bridges need attention People can't manage 10acres

Weeds Forestry Conditions of roads due to forestry trucks Rural roads are not wide enough Forestry is moving towards harvesting 24hours a day Longer travel required to get into town Conversions of forestry to dairy – more adverse environmental effects associated with dairy including sediment into the rivers, practices of dairy Need to protect native bush Mind shift from production to retiring pieces of land Little opportunity for work in rural villages

## **General Comments**

CBD is restricted geographically and surrounded by multiply Maori owned land Performance standards need to be right Need to retain and protect native bush With an aging population, there will be more retirement subdivisions Use protection as guidance eg Ohiwa Strategy Need to raise the awareness of RAP's and SNA's Need to raise awareness of areas of significance through DP Philosophical approach needs to be right – land first, then people

Maori owned land – need to get to know peculiarities of Maori owned land Administrative difficulties with developing Maori land Occupy and manage Maori land as a taonga into the future Owners are caretakers Maori tied to land, others are there to make a profit How do you value land you can't sell? Eg rating of Maori owned land Location of waste transfer station – it is a long way for rural people to come, leads to rubbish being dumped on the side of roads around the community 2 processes for development of Maori land – Maori Court and RMA Council should have jurisdiction over functional things eg stormwater, wastewater, road access etc. Council shouldn't have any interest I who owns the land Answers lie in performance standards and permitted activities Land locking and access to water are the most difficult issues to resolve Maori land should not be rated as if it could be sold on the open market

Pamphlets for rural subdivision are required so that people understand the rules. Need for a pamphlet outlining people's expectation when moving into the rural environment eg "so you're moving into the country?" Distribute pamphlet package to rural real estate agents

Concerned that Government is claiming Maori owned native bush as their own for carbon credits

## Add in new performance standards

lwi wish to assist Council write rules addressing cultural issues eg recommending protection of a place or feature
