## My submission is:

- Whakatane Mill Limited OPPOSES the rezoning of the properties from light industrial to residential.
  - Within the proposal there is no consideration given to the close proximity of the major industrial activity of Whakatane Mill (zoned Industrial refer WDP 3.1.13.1).
  - The noise assessment undertaken by Hegley Acoustics Consultants does not identify Whakatane Mill as a possible source of noise. It only identifies noise sources from the neighbouring light industrial zone and traffic noise. In reference to Rule 11.2.6, Table 11.1 does not recognise noise generated from Industrial zone.  Sections 5.4 and 5.5 of the proposal, whilst acknowledging that there will be reverse sensitivity effects related to the light industrial zone, there is no regard given to the 20 hectare industrial site located to the south and within 100 metres of the proposed development. Whakatane Mill has been in existence for almost 80 years, and is a major source of employment in the Whakatane District. By the very nature of such an industrial site, there are possible noise, light, traffic, emissions and other environmental effects, which should be considered in a reverse sensitivity assessment, in any rezoning proposal - particularly to residential.

## I seek the following decision from the local authority:

To give due regard to existing use rights of major industry within close proximity of the proposed rezoning from light industrial to residential zone.

Reverse sensitivity clauses must be considered within the scope of the proposal, which should be extended to include Whakatane Mill, not only that of the light industrial area.
