7.1 July – December 2024 Six Monthly Climate Change Update

Manager Strategy and Policy and Strategic Analyst, G Mischefski-Gray, spoke to the report, which covered progress on targets and actions outlined in the climate strategy. The report featured a new and simplified format, with a correction noted for an emissions target typo. Key actions included successful climate change workshops and the development of a decarbonisation plan. The report also introduced a climate assessment in the council reporting template.
