### 4 PUBLIC FORUM

#### 4.1 Kids Unplugged - Anton Steel, K Steel and M Steel

Outlined the documentary podcast series focusing on the harms of screen addiction and social media overuse among young people. They have requested funding to produce five new episodes of the web series, covering hours of organising, filming, and editing.

### 4.2 He Rourou, He Rotarota - Rangipare Ngaropo

Miss Rangipare presented application for a multi-sensory black-tie event in December, which would showcase her poetry and other live performances, offering an immersive experience of Māori culture.

### 4.3 Tukutuku Basics - Sonny Hape and Glenda Hape

Miss Rangipare presented application for a workshop introducing participants to tukutuku (traditional Māori wall panel) weaving, fostering cultural connection and creativity open to all in the community with no prior experience.

### 4.4 Tapa Moana Nui - Amy Korenhof

Miss Korenhof has requested funding to support workshops, and an artist talk as part of their opening exhibition, aimed at sharing traditional knowledge and promoting diverse art forms.

### 4.5 Te Whare Rakau Whakapai Kura Wananga - Haupai Williams, Danny Simon and Tukirunga Perenara

The group has requested funds to assist with community Mau Rākau workshops, focused on teaching traditional martial arts, leadership, and teamwork. These sessions were aimed at sunning alongside school holidays every.

#### 4.6 Te Ahi Tahutahu Trust - Wairere Iti

Requested funds for Te Māramatanga o te Ātea, a public installation combining sculpture, projection mapping, and LED light, celebrating mātauranga Māori.

### 4.7 Whakatāne District Community Arts Council Incorporated – Elly Sharp

Requested support for a lantern-making workshop for children and families, aimed at enhancing community spirit and contributing to the Lights on Parade.

### 4.8 Mural at Te Kura Kaupapa Maori o Te Orini Ki Ngati awa - Jarrod Dodd

Sought support to create a mural honouring Koro Tutua at Te Kura Kaupapa Māori o Te Orini ki Ngāti Awa, aiming to inspire pride and kōrero around local leadership.

### 4.9 Songwriters of Aotearoa - Mack Apaapa and Tammy Viitakangas

Requested funding for a national event allowing Aotearoa-based songwriters to showcase original work, gain exposure, and win prizes.

#### 4.10 Waioroariki - Reremoana Rota

Sought funding for a two-day taonga pūoro (Māori musical instrument) workshop, offering participants hands-on learning and the chance to create an instrument to take home.

Sought support for a whole-school musical theatre production the Seussical, aiming to give students an educational and confidence-building experience in the arts.

### 4.12 Stage Door Productions Charitable Trust - Claire House (video)

Requested support for their youth production of Newsies Jr, featuring 41 young performers and aiming to build confidence and develop theatre skills.

### 6.1 Creative Communities Scheme - May 2025

The following members declared a conflict of interest and did not participate in the discussion or vote on the relevant application:

The Community Funding Advisor presented the report, and the following points were highlighted in the discussion:

- It was confirmed that all applicants had completed their required accountability forms.
- Members reviewed the fund guidelines and noted the proposed timetable for advertising Creative Communities Scheme (CCS) funds.
- Members discussed maintaining precedent for applications.
- Members considered the appropriateness of funding wages and professional fees through the scheme.
- The Kids Unplugged project did not meet the Creative NZ guidelines.

- Members discussed whether certain events, given their ticket pricing structure, could reasonably be expected to achieve self-funding rather than requiring funding support.
- Members discussed applications related to school curriculum and how well they aligned with the eligibility criteria. Discussion included consideration of marae-based whaananga delivered through Te Koputu or similar cultural initiatives.
- No retrospective funding would be provided.
- Discussion occurred regarding including provisions for prize money and judging panels for local events. The Board considered an application from Songwriters for Aotearoa, noting the organisation's intention to develop the event into a national programme. Members discussed whether this constituted a private or community-focused event.
- The Board discussed the value of running preparatory workshops ahead of main events to enhance community benefit.
- Members considered artwork projects based in Whakatāne and the associated networking and community hub opportunities these might provide.
