## **4 PUBLIC FORUM**

### **4.1 Iramoko Marae Charitable Trust – Mereana Hona**

M Hona presented a funding proposal on behalf of their Marae, outlining an eight-week Te Reo Māori revitalisation programme. This initiative, which incorporated both online modules and three marae-based gatherings, was designed to accommodate learners of all proficiency levels and had previously engaged up to 200 participants. The application sought financial support for facilities, facilitators, resources, and technology, aiming to strengthen cultural heritage and foster greater community involvement.

### **4.2 Mereana Hona**

M Hona explained that Te Kotahi O Te Ao O Te Atua, a collective forum involving multiple iwi, had been established to build cultural capacity through wānanga and other initiatives, with approximately ten Wānanga conducted over two years. The application for funding was to run a one-day wānanga, aiming to build cultural capacity and strengthen Te Reo Māori across the region, with activities welcoming all proficiency levels and fostering community engagement.

### **4.3 He Taonga Consultancy – Tāne Cook and Kirby Tukere**

He Taonga Consultancy presented their application to deliver a ten-week programme focused on revitalising Te Reo Māori. The initiative has engaged over 200 learners since 2023. It supports progression into further education and vocational pathways. The organisation is seeking funding for facilitators, resources and community events. Their goal is to promote development and strengthen the local community.

### **4.4 Miss Rangipare Ngaropo**

Miss Rangipare Ngaropo outlined her proposal to publish a bilingual children's book, "Ngā Tapuwae O Te Kura", based on local Ngāti Awa history and designed to promote Te Reo Māori and cultural education among tamariki and the wider community. She sought funding to support printing costs, highlighting the book's educational value and its role in addressing a shortage of bilingual resources.

### **4.5 Te Makaurangi o te Tini o Toi (Kaimahi Maori Forum for staff working at Whakatane hospital) – Aporina Chapman, Hatea Ruru and Leeann Waaka**

The Kaimahi Māori Forum presented their application for a three-stage project to introduce bilingual signage at Whakatāne Hospital, aiming to promote Te Reo Māori and enhance cultural visibility for staff and visitors. The forum sought funding for signage design, installation, and community engagement activities, and emphasised collaboration with local iwi to ensure cultural significance and inclusivity.

**Attendance:** A Chapman, H Ruru and L Waaka left the meeting at 9:47 am.

### **4.6 Hospice Eastern Bay of Plenty – Margaret Kempton and Bryce Sheedy**

Hospice Eastern Bay of Plenty sought funding to deliver staff training focused on Te Reo Māori, Tikanga, and cultural safety, with the intention of improving communication, trust, and culturally appropriate care for Māori patients and their Whānau. The programme aimed to enhance staff capability and foster a supportive environment for end-of-life care.

#### 4.7 Mana Ako – Video submission from Lee Palamo

A video submission from Lee Palamo detailed recent research into the application of artificial intelligence for language revitalisation. The video addressed the ongoing impact of language decline and described the development of a self-funded project, with over 400 hours invested to create an app supporting AI-assisted Te Reo Māori learning. The project seeks funding to facilitate an iwi-led launch of the learning tool, which aims to support language normalisation and provide an accessible resource for everyday practice of Te Reo Māori.
