8.1 Matatā Wastewater Project Update – August 2025

Refer to pages 21-62 of the agenda.

The Co-Governance group outlined the longstanding history of wastewater issues in Matatā, emphasising the importance of community and lwi engagement through the co-design process. Technical evidence, including peer-reviewed reports and years of environmental monitoring, confirmed that human wastewater contamination was widespread, with existing septic systems unable to address the risks. Three options were considered, financial risks were discussed, particularly regarding the Ministry of Health subsidy, and legal and cultural obligations were acknowledged.

8.2 Three Waters Consent Replacement Programme Update Report – September 2025

Refer to pages 62-68 of the agenda.

The Manager Policy Planning and Consents and the Senior Three Waters Project Planner provided an update on the Three Waters Consent Replacement Programme. It was recognised that, following enactment of the Local Government Water Services Bill, wastewater consents had been extended by three years. This alleviated immediate time constraints and enabled improved project planning. The Committee was informed that technical teams had commenced project procurement and options development, with co-design processes involving iwi partners underway. Efforts continued to secure alternative water supplies for vulnerable sites, supported by ongoing consent applications.

8.3 Keepa Road Shared Use Path Options Report

The Manager Transportation presented the report, and members considered a range of options for the Keepa Road shared use path. It was noted that further upgrades would be reviewed in the 2027–2037 Long Term Plan, subject to funding decisions from the New Zealand Transport Agency. The discussion included incremental improvements, alternative funding sources, and the immediate addressing of safety concerns through reactive maintenance within the current budget.

8.4 Battery Town Rally, Christmas Parade and Atea Block Party Event Road Closures

Refer to pages 84-91 of the agenda.

The Technical Administrator Transportation presented the report and informed members that the event organisers had engaged with affected residents and businesses regarding proposed temporary road closures, which were recommended for approval.

It was acknowledged that closures would be time-limited to minimise disruption, and that costs for traffic management would be waived for not-for-profit organisations, excluding publication charges.

- 2. THAT the Infrastructure and Planning Committee **recommends** that Council **approve** a temporary road closure on Rendall Road (full length), Manawahe Road (from WDC District Boundary to Rendall Road), Herepuru Road (from 400m prior to Gate 290 to gate 1096A), Cambell Road (from Pikowai Road to WDC District Boundary), on Saturday, 11 October 2025, between 05:40am to 6:00pm, to accommodate the Battery Town Rally event; and
- 3. THAT the Infrastructure and Planning Committee **recommends** that Council **approve** a temporary rolling road closure for the Christmas Parade event, departing from St Joseph's School, King Street, and proceeding along King Street (St Joseph's School to Haig Street), Haig Street (King Street to Russell Street), Russell Street (Haig Street to Domain Road), Domain Road (Russell Street to McGarvey Road), McGarvey Road (Domain Road to Peace Street), Peace Street (McGarvey Road to The Strand), and The Strand (Peace Street to Kakahoroa Drive), on Saturday, 20 December 2025, between 11:00am and 1:00pm; and
- 4. THAT the Infrastructure and Planning Committee **recommends** that Council **approve** a temporary road closure on The Strand Service Lane (halfway between The Strand and Bracken Street), on Friday 19 to Sunday 21 December 2025, between 12pm (Friday) to 5pm (Sunday), to accommodate the Atea Block Party.
