8.1 Whakatāne Airport Statement of Intent (SOI)2024 - 2027

Manager Ports and Airport Chief Executive presented the report and noted that the OPEX expenditure for 2023/2024 (referenced in section 7 of appendix 1) would be updated before being presented for final adoption by Council.

- The narrative relating to sustainability (page six) be expanded to reflect that the airport is working to gain financial sustainability.
- Korero be included to emphasise the relationship iwi and hapū have with the whenua and the commitment Council must further deepen these relationships.

8.2 Three Waters Consent Replacement Programme Update Report – July 2025

The Project Manager and Senior Water Consents Project Planner presented the report and highlighted that the focus had been on water consent renewals and the development of engagement plans. The Tāneatua consent had been lodged, with other consents managed through a combination of in-house and consultant delivery. Early work had also commenced on wastewater consents, with progress dependent on the release of updated standards expected later in the year. It was noted that a cost-effective approach was supported using experienced planners.

- The current speed limit for Site 18 (Ōhope Road) had been incorrectly recorded; it was clarified that the existing speed limit was 80 km/h, with a proposed reduction to 60 km/h.
- Further information regarding variable speed limits outside schools would be brought to a future Infrastructure and Planning Committee meeting.
