# 7.1 Submission on the Local Government (System Improvements) Amendment Bill

Refer to pages 18-28 of the agenda.

The Manager of Strategy and Performance, together with the Senior Strategic Policy Analyst, presented the report and the following points were highlighted:

- The bill's intention was to refocus local government on core services and cost-effectiveness.
- It was noted that the submission was broadly aligned with Local Government New Zealand's draft response, with an emphasis placed on key issues rather than a clause-by-clause analysis.
- During discussion, concerns were raised regarding the bill's definition of core services, which
  was said to exclude several legislatively required functions. Councillors stressed the importance
  of providing suitable funding mechanisms to alleviate pressure on rates.
