The Bay of Plenty CDEM Group support the proposed Bay of Plenty plan of action of managing the risk of the Awatarariki debris flow by prohibiting residential activities while they also support "the managed voluntary retreat strategy running in parallel with this process".

The reasons for my opposition are:

There is no guarantee that the managed voluntary retreat strategy will be approved by central government, Bay of Plenty Regional Council, or Whakatane District Council.

There is no consideration in the Bay of Plenty CDEM Group's submission of what will happen to the families who are forced to leave their homes with no compensation if the managed voluntary retreat strategy is not progressed. These families will in effect become homeless.

In the Summary of Decisions provided by the Councils neither the Bay of Plenty CDEM Group nor Te Runanga o Ngati Awa's relief of support for or expectation of compensation was recorded as part of their submission.¹²

- remove homes and families from a location that is in harm's way
- bring certainty to these families and the community
- ensure central government agencies contribute financially to the relocation of families into new homes in a safe location

• protect people from making future investments in residential subdivision at this location by inserting a prohibited activity rule for residential development at this location which would place people in harms way, at night, when they and their families and any guests are sleeping.

• the prohibited activity status will protect people from making future investments in building their homes in this high-risk location

• the permitted activities status will allow for people to continue to enjoy appropriate activities at the location"

The reasons for my opposition are:

There is no guarantee that central government agencies will contribute financially to the relocation of families into new homes in a safe location.

There is no consideration in Te Runanga o Ngati Awa submission of what will happen to the families who are forced to leave their homes with no compensation if central government agencies do not contribute financially to the relocation of families into new homes in a safe location. These families will in effect become homeless.

In the Summary of Decisions provided by the Councils neither the Bay of Plenty CDEM Group nor Te Runanga o Ngati Awa's relief of support for or expectation of compensation was recorded as part of their submission.³⁴
