

## AVAILABILITY OF SUMMARY OF DECISIONS REQUESTED ON PROPOSED PLAN CHANGE 1 TO THE WHAKATĀNE DISTRICT PLAN AWATARARIKI FANHEAD, MATATĀ FOR FURTHER SUBMISSIONS

Whakatāne District Council has prepared a *Summary of Decisions Requested* on Proposed Plan Change 1 to the Whakatāne District Plan. Further submissions are now sought on the submissions that have been made.

- Edgecumbe Library, 38 College Road, Edgecumbe;
- Murupara Library and Service Centre, Civic Square, 48 Pine Drive, Murupara; or
- Ōhope Library, 4 Harbour Road, Ōhope.

Under clause 8(1) of Schedule 1 to the Resource Management Act 1991, the following persons may make a further submission:

- (a) any person representing a relevant aspect of the public interest, and
- (b) any person that has an interest in the proposed plan change greater than the interest that the general public has, and
- (c) the local authority.

A further submission may only express support for or opposition to a matter raised in an original submission (made under clauses 6 or 6A of the Resource Management Act 1991) and must not raise new points of submission. Further submissions must be lodged using the prescribed RMA form (Form 6), which can be completed online, downloaded from the Whakatāne District Council website at whakatane.govt.nz/documents/council-plans/operative-district-plan-2017, or collected from the libraries listed above.

A copy of the further submission is also required to be sent to the original submitter not later than five working days after lodging the 'further submission' with the Whakatāne District Council (Clause 8A, Schedule 1).

Further submissions must be lodged by no later than 4:00 pm on Tuesday, 11 December 2018.

Following the close of further submissions, a report will be prepared on the proposal and a hearing date will be set and notified to all submitters and further submitters who wish to be heard.
