## Project snapshot for the Rangitāiki area

ere is a snapshot of some of the key projects proposed for the Rangitāiki Community Board area for the next 10 years. ## Edgecumbe water supply upgrades

We're proposing to make some improvements to the water supply network in Edgecumbe, to ensure that there is enough water pressure available for effective firefighting throughout the urban area. Council has set aside \$450,000 in its budget for the 2019/20 period of the Long Term Plan.

## New Sewerage Reticulation System for Matatā

The Matatā sewerage treatment project is a major undertaking and will provide all households in Matatā with an effective and environmentally responsible sewage disposal system. The availability of Ministry of Health funding (\$6.7 million) and a grant allocation from the Bay of Plenty Regional Council (\$1.88 million) means that this project can be carried out at an affordable cost to the community. A total project cost of \$13.2 million has been estimated, about one-third of which will be funded by all District ratepayers who are connected to Council sewerage schemes. Subject to the outcome of the recent Environment Court hearing, work is expected to begin in 2015/16.

# Edgecumbe Sewage Treatment Plant upgrade


The resource consent to discharge treated effluent from the Edgecumbe Sewage Treatment Plant is due to expire in 2026. To obtain a new resource consent, we may have to carry out upgrades to the existing treatment plant and improve treated effluent quality. Council is proposing to set aside \$4.05 million for this work, to be carried out in the 2015-18 period of the Long Term Plan.

### Rewatu Road improvements

Rewatu Road, and a number of other roads in our District, are prone to flooding during storm events. We are looking to investigate ways to improve the resilience of these roads. The Long Term Plan proposes to set aside approximately \$1 million to carry out any necessary improvement works for Rewatu Road in the 2024-25 year.

## Plains Water Supply

Development of a new water supply bore at Paul Road and pipe connections extending to Awakeri and Edgecumbe are expected to be completed by the 2015/16 year. Further implementation of the Plains Water Supply Strategy is proposed to be put on hold until further work is completed on the financial and economic viability of the project.



# Proposed rate changes

The following average rates increases would apply if the Long Term Plan is adopted with no significant changes.

for 2015/16

#### EDGECUMBE

Average properties in Edgecumbe (capital value \$205,000) would see an increase in rates costs of around 1.24%. This is significantly lower than the district average of 3.20% and would represent an increase of about \$33 increase on the current annual rates cost. This is principally due to increases to the General Rate requirement and the Uniform Annual General Charge to cover the impact of inflation on the cost of Council services, offset in part by small reductions in other areas. Edgecumbe sewerage rates also increase slightly.

#### TE TEKO

Average properties in Te Teko (capital value \$101,000) would see increases of 2.18%. These are below the District average of 3.20% and would represent about a \$35 increase on the annual rates bill. This is principally due to increases to the General Rate requirement and the Uniform Annual General Charge, offset in part by small reductions in other areas.

#### MATATĀ

Rates for an average Matatā property (capital value \$226,000) will decrease by 0.73% or a reduction of \$20.70 in the rates bill. This can be attributed to Council's decision to use general rates to fund Matatā Disaster Mitigation stormwater costs. This change will be phased in over three years, increasing the general rate funding of disaster costs from the current 75% to 100%. Also of note is that, subject to the completion of Matatā's new sewerage system, a new rate would need to be implemented from 2016/17. All ratepayers with properties connected to, or able to be connected to the sewerage scheme will see a rates increase in that year.

#### RURAI HIGH

The average high value rural property (capital value \$2.37 million) will see a 2.30% rate increase, which equates to about a \$156 increase in the annual rates bill. This is principally due to an increase in the general rate requirement, which is offset in part by a decrease in the capital value-based roading rate.

## Key services provided in the Rangitāiki area

hakatāne District Council is responsible for delivering a wide range of essential services and facilities including water supplies, sewage treatment and disposal, solid waste management, roads and footpaths, parks and reserves, libraries, economic development and animal control, to name a few. Additionally, many key services located in the Whakatāne township also provide services to the communities of the Rangitāiki area such as the Whakatāne Museum and Research Centre, Whakatāne Aquatic Centre and War Memorial Hall.

Some examples of key services located in the Rangitāiki Community Board Area include:

- Matatā, Edgecumbe, Te Mahoe and Plains Water schemes
- Edgecumbe, Te Mahoe and (from 2016/17) Matatā Sewerage Systems
- Edgecumbe, Te Teko, Te Mahoe and Taiwhakaea Stormwater Systems
- Weekly rubbish and recycling and fortnightly greenwaste collections

- Extensive road network
- Multiple reserves and sports fields
- Thornton boat ramp
- Community Halls at Edgecumbe, Awakeri, Manawahe, Otakiri and Te Teko
- Edgecumbe Library
- Matatā (Awakaponga) Cemetery.
